PRESIDENT'S COLUMN

Dear Academy Members,

Our meeting in San Diego was a wonderful experience, and you will have the chance to read about it in the Forum and Newsletter.

Congratulations to Jim Edwards, MD and Carlo Filiaci, MD, meeting co-chairs, as well as the tireless Gerry Perman, MD, Chair of Scientific Programs, for a job well done.

I want to remind you about our Winter Meeting, which will be held this year on December 8, 2007 in cooperation with the Department of Religious Studies at the University of Arizona, Tempe. Entitled, "Psychodynamic Psychotherapy and Spirituality," it is being chaired by Mariam Cohen, MD, PsyD, Chair of our Psychoanalytic Education Committee and the Website and Electronic Communications Committee. Dr. Cohen is also Chair of the Religious Studies Department at the University of Arizona.

Council will meet the day prior to this one-day meeting, and the meeting day will include our regular Business Meeting. Deadline for abstract submissions is the end of this month. The form is available on our website. We are hoping to see you there!

Enclosed is a Call for Papers for our May 2008 Annual Meeting in Washington, DC. Program Chairs are David Lopez, MD and Joseph Silvio, MD, who have chosen the theme of "Nature and Nurture in the XXI Century." Excellent keynote and opening night speakers have already been recruited. Be sure to save the dates--earlier in May than usual.

Our meeting in San Diego was the opportunity for me to unveil two new initiatives for the Academy: The Victor J. Teichner Master Teacher Award, and the Annotated Bibliography Project. I hope to enlist every member of the Academy to participate in at least one of these projects in the coming months.

Victor J. Teichner was President of the Academy for only a week before his untimely death 24 years ago. A grateful patient has given our Academy a grant to set up a teaching fellowship in his name, to be given to a [Scholar] member of AAPDP. The money will be used to support the Scholar to travel to a residency training program underserved in the area of psychodynamic education. We have long dreamt of a "Speaker's Bureau"; of sending our members to teach throughout the country, but we never had the means to pay for it. This grant will allow us to use the interest to pay for one Scholar each year, thus ensuring the award for future generations. We are partnering with the AADPRT (American Association of Directors of Psychiatric Residency Training) in the administration of the Award. The Selection Committee (consisting of 3 members of the Academy and 3 AADPRT members) will choose the training program each year from those who apply to host a Scholar. The selected training program will choose the Scholar from our list.

We have decided to ask the programs and the Scholar applicants to submit their materials in electronic form, thus making it possible to keep our overhead costs to a minimum from the start, and ensuring easy communication. The materials for members to apply as Scholars are on our website. Please add your name, your areas of interest, and your CV to our database. If you have further questions about this project, feel free to contact me or the Academy Office.

A second initiative, the Annotated Bibliography Project, was conceived as another way to make our members' knowledge of the psychoanalytic and psychodynamic literature available to trainees. Although they have libraries of materials available, and may, in fact, find "reading lists" or curricula on-line, there is no guidance to the articles. Those of us familiar with the literature usually know what to expect from particular authors. For example, we might be familiar with the author's

FROM THE CO-CHAIR 2007 WINTER MEETING

The Winter Meeting of the AAPDP is being planned for Saturday, December 8, 2007, on the campus of Arizona State University in Tempe, Arizona. Our meeting is being hosted by the Department of Religious Studies at the University, and the topic is Psychotherapy and Spirituality. Cynthia Geppert, MD, will be the Keynote Speaker. Dr. Geppert is on the faculty of both the University of New Mexico Medical School and the Department of Religious Studies at UNM. She will be speaking on the role of religion and ethics in psychotherapy. Other speakers

theoretical bias, or developmental point-of-view, which will help in decoding the contents of the article or book. All of us are familiar with bringing particular "favorite" articles to the attention of our trainees. I have asked Nancy Joachim, MD and Eve Leeman, MD, to be the Editors for the project. Our job will be to start with 100 "basic" articles in the psychodynamic/psychoanalytic canon for annotation. The bibliography will be available through our website, and will be linked with the APA and AADPRT websites, giving trainees easy access to the materials. In order to get this project "off the ground" over the next few months, I am asking each one of our members to annotate one article from the "basic 100." As soon as these are completed, we will open the project to new submissions. At a later date, we plan to add a bibliography of annotated books, with Cesar Alfonso, MD, as book editor. If you have a favorite article [and/or book], annotate it, and we will post it! All annotations will be signed (*wiki-style*), and we will certainly entertain conflicting annotations, in the spirit of academic freedom. So watch for the announcements of the Grand Opening --the posting of the Annotated Bibliography Project on our website.

During the first year of my Presidency I have sought to raise the "profile" of the Academy; to have our name associated with the training of psychodynamically-oriented clinicians, researchers, and scholars. In order to accomplish this, we must make the most of our links with other organizations in mainstream psychiatry. With these two projects we build on our link to the APA and forge a new link with AADPRT. Our name and our members will be featured at each of their Annual Meetings with the presentation of the Award to the Residency Program and Scholar. But remember: the success of these projects depends upon the participation of each of our members. I look forward to working with you during the coming year!

Grant Hilary Brenner, MD, New York, NY

Dr. Grant Brenner is a psychiatrist in New York City, and a Clinical Instructor in the Department of Psychiatry at Mount Sinai. Arnold Cooper, MD, New York, NY

Dr. Arnold Cooper is cited for Honorary Membership by Dr. Joan Tolchin, in the following Memo to the Chair of the Membership Committee:

“I would like to recommend Dr. Arnold M. Cooper for Honorary Membership in the American Academy of Psychoanalysis and Dynamic Psychiatry. Dr. Cooper, a distinguished and internationally respected psychiatrist and psychoanalyst, will be presenting the Keynote Address at the Academy's 51st Annual Meeting in May, 2007. Dr. Cooper, a Life Fellow of the American Psychiatric Association, is Professor Emeritus in Consultation Psychiatry at Weill Cornell Medical College and a Training and Supervising Analyst at the Columbia University Center for Psychoanalytic Training and Research. Dr. Cooper is a past President of the American Psychoanalytic Association, was a Fellow on its Board on Professional Standards and is a past Vice President of the International Psychoanalytic Association. At Cornell, he was

Associate Chairman for Education and Director of Training for fourteen years. Dr. Cooper is the recipient of numerous awards and honors including the George S. Goldman Award for Achievement in Clinical Psychoanalysis and/or Psychoanalytic Education, Columbia Center for Psychoanalytic Training and Research. In addition, Dr. Cooper is a prolific and respected author, as well as an Editorial Board Member of important journals including the *Journal of the American Psychoanalytic Association* and the *Revue Internationale de Psychopathologies*. Dr. Cooper's writings and work reflect his humanistic and rigorously intellectual approach to psychiatry and psychoanalysis which would make him an important member of our Academy.”

Leo Rangell, MD, Los Angeles, CA

In his review of Dr. Rangell's latest book *My Life in Theory* (2004) for the *Journal of the American Academy of Psychoanalysis and Dynamic Psychiatry*, Dr. Harold Bronheim said the following: “Dr. Leo Rangell, perhaps the pre-eminent living psychoanalyst in the world, has written and presented over 450 articles and 7 books. He has been President of the American Psychoanalytic Association twice, President of the International Psychoanalytic Association, and is currently Honorary President of the IPA since 1997 – a post held previously only by Ernest Jones, Heinz Hartman, and Anna Freud. In his latest book (and we hope not his last) he has produced a *tour de force* which may perhaps be considered the most important psychoanalytic book since Fenichel's two volume set on the *Psychoanalytic Theory of Neurosis* in 1945. Dr. Rangell has practiced, lectured, and led for six decades. He has witnessed the evolution of psychoanalysis through the second half of its 100 year history. He has personally known and collaborated with all the great personalities who have crafted the field over the past 50 years.”

This year, 2007, the Trustee's dinner was held in a private room at Grant Grill, just before the opening night of our Annual meeting in San Diego. Jerry Perman, MD entertained the trustees with his super-fine folk and blues finger-picking guitar! Jerry's music punctuated

the topics on which each Trustee spoke. Special thanks to Charmaine Rapaport, MD and Mark Novick, MD, who organized the dinner.

New Trustees honored included Gail Berry, MD, Shelly Galler, MD and David Lopez, MD. Trustees in attendance included Paul Fine, MD, Nancy Joachim, MD, and Charmaine Rapaport, MD (2007), Hae Kim, MD, Jay Lefer, MD, and Jerry Perman, MD (2008), and Jim Edwards, MD, Mark Novick, MD, and Astrid Rusquellas, MD (2009).

Topics discussed included: Introduction to the Constitution and Bylaws, Policy and Procedures Manual, and a description of Committees and how to be assigned to a committee.

FROM THE APA ASSEMBLY ALLIED ORGANIZATIONAL LIAISON GROUP

I have enjoyed continuing to serve as the Academy's representative to the APA Assembly through the group of Assembly Allied Organization Liaisons [AAOL] and as a member, with Jack Drescher, of the Academy's APA Relations Committee. In May the Assembly met for 3 days in San Diego, where I attended the Assembly plenaries and meetings of APA Area I (New England and Eastern Canada), served as a member of the AAOL group and Assembly Procedures Committee, and chaired one of the 5 Assembly Reference Committees that reviews and makes recommendations about support of action papers that come before the full Assembly for a vote. I was part of a minority of Assembly members voting to support maintaining a dialogue with psychologists about psychologist prescribing, and was disappointed that the larger Assembly voted not to recommend that APA staff and leadership continue such efforts to talk about the issues.

The AAOL group of organizations within the Assembly was established as an experiment some years ago. In May, I participated in AAOL

discussions with a representative of the Assembly Executive Committee about the value of continuing AAOL representation in the Assembly, speaking strongly in favor of continuing the relationship. Among other issues, there were discussions about whether the Assembly would begin to fund some of the travel of AAOL representatives. Currently AAOL representatives or their organizations fund the cost of travel, unlike the case with geographically elected Assembly members. The Academy does not support the travel costs of its AAOL representative.

An issue within the APA that will be of importance over the next several months is the second edition of the *Practice Guideline for Panic Disorder* that is currently in draft form. Most of us probably know about the randomized controlled trial carried out by Barbara Milrod and colleagues and recently published in JAPA. This important study found panic-focused psychodynamic psychotherapy to be superior to a form of behavioral treatment for panic disorder, and replicated results from a previous open trial of treatment. However, the most recent draft of the soon to be published *Panic Disorder Practice Guideline* does not include psychodynamic therapy as a first-line treatment for the disorder, citing only CBT and medication as first-line treatments. I and others are pressing the Practice Guideline Committee to reconsider psychodynamic therapy as a first-line treatment. Eventually the *Guideline* will come before the full Assembly for a vote. I hope to avoid a floor fight about this issue by dealing with it before the final draft is offered.

I also serve in the APA Components as chair of the Committee on Psychotherapy by Psychiatrists [COPP], which also met in San Diego. This group is involved in several projects. Perhaps the most exciting is our effort to develop a model curriculum for teaching schools of psychotherapy from a unified and integrated perspective. The approach, called the Y-Model, is based on the comparative psychotherapy process research literature. It teaches core features across all schools of psychotherapy (e.g., negotiating an alliance, empathic listening) as part of the stem of the Y, and then compares and contrasts the research-derived core features of psychodynamic therapy and CBT as the forks of the Y. The Y-Model has been well-received by trainees, residency training directors, and by members of the APA Council on Quality Care, which I attend as chair of COPP.

While in San Diego I also was part of the scientific program of the APA annual meeting. APA presentations this year included chairing and presenting at a COPP workshop on our Y-Model curriculum, chairing 2 other workshops on clinical issues concerning suicide, and once again this year directing and teaching a full-day course entitled "A

psychodynamic approach to treatment refractory mood disorders" with colleagues from Austen Riggs.

The work of the APA is central to us as medical psychoanalysts and dynamic psychiatrists. I urge you to renew your APA membership this year (or re-join if you have let your membership lapse). Having Academy members [*who are also*] APA members is required to maintain our role as an Allied Organization. It is also the best way to ensure that we may continue to serve the field and our patients as a voice for dynamic psychiatry within the APA.

VIEW FROM THE PRESIDENT-ELECT OF THE APA

Every group of psychiatrists worries about APA attention to the issues it holds dear. It is my sense, after years in the Assembly and on the Board, that there is commitment to psychodynamic psychotherapy in both bodies and on the staff. The recent increase in empirical research will do much to bolster that commitment, and to insure that psychotherapy is included in APA practice guidelines as they are developed and updated. While clinical experience will continue to be respected, pressure for empirically validated approaches is only going to grow. Official quality measures, for example, tend to include the initiation and continuation of antidepressant medication, with psychotherapy accepted only if medication is documented as inappropriate. The APA staff are working actively to change this requirement.

'Pay for performance,' and APA participation in the development of standards, will continue to be controversial, with some members asserting that any collaboration is a betrayal of medical ideals, and others convinced that the imposition of performance measures is inevitable, and that it is best to work to make them as fair and relevant as possible. I take the latter view, and whatever slings and arrows come with it. We have to understand that people and institutions that pay for treatments have some right to demand evidence that their money is well spent--along with the obligation to provide what they promise and to justify their own decisions.

We have spent too much time complaining after the fact. We need to understand the risks and benefits of different health system arrangements, and to think about what kind of health care system we want, rather than what is wrong with each possible system.

Psychoanalytic principles can help us understand and address the barriers to that crucial discussion. We must participate in shaping the system we want, and we need to be prepared to provide compassionate and thoughtful care, and to have gratifying work lives, in the system we get. It is my hope to provide the background and incentives for us to engage in this major struggle and to insure that psychodynamic psychotherapy and psychoanalysis survive and prosper in its outcomes.

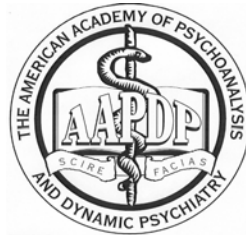
